

Free virtual hazmat training session terms and conditions

- The free virtual hazmat training session can only be won once by any member of the same organisation (irrespective of country) during the two quizzes on each day of the event.
- Participants can enter the quiz alone or as a team. A team must be made up of registrants from the same organisation.
- The winner of the quiz (whether a single individual or a team) can extend the opportunity to take part in the free virtual hazmat training session to a maximum of 20 people in their organisation, including the ones who were part of the winning team.
- Everyone who is put forward to take part in the winning session should have registered for the Virtual Hazmat 2021. Unregistered employees cannot take part in the free virtual hazmat training session.
- Organisations who have previously trained with the Hazmat Academy, cannot run the same course they have already trained in, for other members of their organisation. However, the organisation will be able to choose another training course if they win.
- An organisation can only win once over the two days; however, everyone will be allowed to compete on either or both days.
- If the same organisation wins on both days, on the second day, the prize will be deferred to the organisation that comes in second.
- The decision as to who wins will be based solely on NCEC's discretion.
- The organisation that wins the quiz will be announced on the same day at the end of the session and will be contacted afterwards either by email or telephone using the contact information provided in the registration form of the winning individual/winning team.
